

# Anthem PA Transition

Express Scripts is committed to serving Anthem, its members, and physicians throughout their transition away from our Coverage Review Department.

**Starting on July 15, 2018**, and continuing in three phases through November 2018, the Anthem commercial coverage review process will change and Prior Authorization support will transition to Anthem.

## Submit Anthem PAs Electronically

The easiest way to submit PA requests is **electronically** through your electronic health record or an online service. Effective immediately, when using an ePA service, after selecting your plan’s state please use the following search terms to ensure your requests are processed correctly:

Member Coverage	ePA Online Search Term
MEDICARE through Anthem	“Anthem Medicare”
MEDICAID through Anthem	“Anthem Medicaid”
COMMERCIAL* through Anthem	“Anthem Commercial”
All coverages through Express Scripts	“Express Scripts”

These search terms may be used at any time and are not date or phase dependent.

*\*Commercial refers to non-Medicare and non-Medicaid plans.*
